ORDINANCE NO. 193

---

AN ORDINANCE

OF THE COUNCIL OF THE BOROUGH OF MILESBERG,  
CENTRE COUNTY, PENNSYLVANIA, GRANTING TO  
MID CENTRE COUNTY AUTHORITY CERTAIN RIGHTS AND  
PRIVILEGES IN, ALONG, OVER AND UNDER STREETS,  
ROADS, LANES, COURTS, CUL-DE-SACS, ALLEYS,  
PUBLIC WAYS, PUBLIC SQUARES AND OTHER PROPER-  
TIES OF THIS BOROUGH FOR USE IN CONNECTION  
WITH SAID AUTHORITY'S SEWER SYSTEM; AND PRO-  
VIDING FOR REGULATING THE MANNER IN WHICH SUCH  
RIGHTS AND PRIVILEGES SHALL BE EXERCISED.

WHEREAS, Mid Centre County Authority (the "Authority"),  
pursuant to the request and consent of this Borough, has agreed  
to acquire and construct a complete sanitary sewage collection and  
treatment system, including all related and necessary facilities,  
for, inter alia, rendering sewage service in and for this Borough  
(the "Sewer System").

NOW, THEREFORE, BE IT ENACTED AND ORDAINED and it is  
enacted and ordained by the Council of the Borough of Milesburg,  
Centre County, Pennsylvania, as follows:

SECTION 1. This Borough does grant to the Authority, its successors and assigns, all easements, rights of way and other rights necessary and desirable in, along, over and under streets, roads, lanes, courts, cul-de-sacs, alleys, public ways, public squares and other properties of this Borough, together with free ingress, egress and regress therein and thereto, along with other persons having interests or rights therein, for use in connection with constructing, replacing, repairing, altering and maintaining the Sewer System to be acquired and constructed by the Authority, as the same shall exist, from time to time.

SECTION 2. The rights and privileges granted to the Authority under Section 1 shall be exercised by the Authority under and subject to such reasonable rules, regulations and conditions as shall be adopted and specified, from time to time, by resolution or ordinance of this Borough; and this Borough does reserve the right to adopt and specify, from time to time, such reasonable rules, regulations and conditions in connection with exercise by the Authority of such rights and privileges.

SECTION 3. This Ordinance shall become effective as provided by law.

SECTION 4. In the event any provision, section, sentence, clause or part of this Ordinance shall be held to be invalid, such

invalidity shall not affect or impair any remaining provision, section, sentence, clause or part of this Ordinance, it being the intent of this Borough that such remainder shall be and shall remain in full force and effect.

SECTION 5. All ordinances or parts of ordinances inconsistent herewith shall be and the same expressly are repealed.
