ORDINANCE NO. 194

---

AN ORDINANCE

OF THE COUNCIL OF THE BOROUGH OF MILESBERG, CENTRE COUNTY, PENNSYLVANIA, AUTHORIZING AND APPROVING AN AGREEMENT, DATED AS OF MARCH 1, 1979, BETWEEN THIS BOROUGH AND MID CENTRE COUNTY AUTHORITY WHEREBY, INTER ALIA, SAID AUTHORITY COVENANTS, INTER ALIA, TO CONSTRUCT AND ACQUIRE A COMPLETE SANITARY SEWAGE COLLECTION AND TREATMENT SYSTEM AND WHEREBY THIS BOROUGH MAKES CERTAIN COVENANTS AND AGREEMENTS WITH RESPECT TO SAID SANITARY SEWAGE SYSTEM TO BE CONSTRUCTED, ACQUIRED AND OPERATED BY SAID AUTHORITY, INCLUDING REQUIRING ALL OWNERS OF IMPROVED PROPERTY LOCATED IN THIS BOROUGH AND BENEFITED, IMPROVED OR ACCOMMODATED BY ANY SANITARY SEWER CONSTITUTING A PART OF THE AFORESAID SEWER SYSTEM, TO CONNECT THEREWITH, AND GRANTING CERTAIN EASEMENTS AND RIGHTS OF WAY TO SAID AUTHORITY; AUTHORIZING AND DIRECTING EXECUTION AND DELIVERY OF SAID AGREEMENT IN BEHALF OF THIS BOROUGH; AND AUTHORIZING AND DIRECTING OTHER NECESSARY AND PROPER ACTION.

The Council of the Borough of Milesburg, Centre County, Pennsylvania, enacts and ordains as follows:

SECTION 1. This Borough shall enter into an Agreement, dated as of March 1, 1979 (the "Agreement"), between this Borough and Mid Centre County Authority (the "Authority"), whereby, inter alia, the Authority covenants, inter alia, to construct, acquire and operate a complete sanitary sewage collection and treatment system and whereby this Borough makes certain covenants and agreements with respect to the Sewer System, as such phrase is defined in the Agreement, to be owned and operated by the Authority, including requiring all owners of improved property located in this Borough and benefited, improved or accommodated by any sewer constituting a part of the Sewer System to connect therewith, and granting certain easements and rights of way to the Authority, substantially in the form presented to this meeting, which Agreement is approved.

SECTION 2. A copy of the Agreement, in the form so presented to this meeting and so approved, shall be filed with the Secretary of this Borough and shall be made available for inspection at reasonable times by interested persons requesting such inspection.

SECTION 3. All ordinances and parts of ordinances inconsistent herewith expressly are repealed.
