

ORDINANCE NO. 195

AN ORDINANCE ACCEPTING ON BEHALF OF MILESBURG BOROUGH ALL THAT PORTION OF VIEW STREET RUNNING IN A WESTERLY DIRECTION FROM ITS INTERSECTION WITH EAST AVENUE TO ITS INTERSECTION WITH WEST AVENUE, ALSO ACCEPTING ALL THAT PORTION OF WEST AVENUE RUNNING IN A SOUTHERLY DIRECTION FROM ITS INTERSECTION WITH VIEW STREET TO ITS INTERSECTION WITH CROSS STREET, ALSO ACCEPTING ALL THAT PORTION OF WEST AVENUE RUNNING IN A NORTHERLY DIRECTION FROM ITS INTERSECTION WITH CROSS STREET TO ITS INTERSECTION WITH VIEW STREET TO BE USED AS PUBLIC ROADS OF SAID BOROUGH.

WHEREAS, the rights of way hereinafter described have been dedicated to the Borough of Milesburg and used by the public and maintained by the Borough of Milesburg since their dedication for a period in excess of twenty-one (21) years.

BE IT ENACTED AND ORDAINED by the Borough Council of the Borough of Milesburg, Centre County, Pennsylvania, and it is hereby Enacted and Ordained as follows:

SECTION ONE: All that right of way known as View Street running in a westerly direction from its intersection with East Avenue along its center line having a bearing North 67° 50' East, and a center line distance of 950 feet, more or less, to its intersection with West Avenue and a width of 48 feet is hereby adopted and accepted as a public road and street of the Borough of Milesburg.

SECTION TWO: All that right of way known as West Avenue running in a southerly direction from its intersection with View Street along its center line having a bearing South 22° 10' East, and a center line distance of 279 feet, more or less, to its intersection with Cross Street and a width of 50 feet is hereby adopted and accepted as a public road and street of the Borough of Milesburg.

SECTION THREE: All that right of way known as East Avenue running in a northerly direction from its intersection with Cross Street along its center line having a bearing North 22° 20' West,

and a center line distance of 283 feet, more or less, to its intersection with View Street and a width of 40 feet is hereby adopted and accepted as a public road and street of the Borough of Milesburg.

BE IT FURTHER ORDAINED that the Borough Solicitor for Milesburg Borough be authorized and directed to file a copy of this Ordinance, together with a draft or a survey of the street herein described in the office of the Prothonotary of Centre County and with the Pennsylvania Department of Transportation.

ENACTED and ORDAINED as an Ordinance of the Borough of Milesburg this 4 day of June, 1979.
