

ORDINANCE NO. 230

AN ORDINANCE OF THE BOROUGH OF MILESBERG APPROVING A CERTAIN AGREEMENT FOR THE PROVISION OF POLICE SERVICES TO THE BOROUGH OF MILESBERG PROVIDING FOR THE EXECUTION, ACKNOWLEDGMENT AND DELIVERY OF THE SAME.

BE IT ENACTED AND ORDAINED, by the Council of the Borough of Milesburg and it is hereby enacted and ordained by authority of the same:

SECTION ONE.

A certain Agreement in substantially the same form as that Agreement attached hereto and made a part hereof as Exhibit A between the Borough of Milesburg and the Borough of Bellefonte for the provision of Police services by the various officers of the Bellefonte Police Department to the Borough of Milesburg is hereby adopted, ratified and approved.

SECTION TWO.

For the duration of said Agreement or any renewal thereof, the Police Officers of the Borough of Bellefonte upon approval by the Council of the Borough of Milesburg of their service shall have the authority within the Borough of Milesburg to impose fines, forfeitures and penalties for the violation of any Ordinance or other law of the Borough of Milesburg or other government having jurisdiction. They shall have the power to provide for the recovery and collection of the same and in default of payment to provide for confinement in the County Prison or to hard labor upon the streets of the Borough of Milesburg or elsewhere for the benefit of the Borough of Milesburg.

SECTION THREE.

It is understood and agreed that the Policemen so appointed by Resolution of the Borough of Milesburg shall however insofar as civil service, pension rights and other matters relating to employment. They shall be deemed to be appointees and employees only of the Borough of Bellefonte which is only furnishing their service. The Police Officers of the Borough of Bellefonte assigned to duty in the Borough of Milesburg shall not be deemed to be borrowed employees or otherwise other than properly appointed Police Officers of the Borough of Bellefonte.

SECTION FOUR:

The proper officers of the Borough of Bellefonte are hereby required, requested, directed and authorized to make, execute, acknowledge and deliver the aforesaid Agreement (Exhibit A) and are hereby required, requested, directed and authorized to do all things necessary and proper to carry out the intention of this Ordinance and the aforesaid agreement.

SECTION FIVE.

All Ordinances or parts of Ordinances inconsistent herewith, are hereby expressly repealed.
