

AN ORDINANCE OF THE BOROUGH OF MILESBERG APPROVING A CERTAIN AGREEMENT BETWEEN THE BOROUGH OF BELLEFONTE AND THE BOROUGH OF MILESBERG FOR THE SALE OF WATER AND PROVIDING FOR THE EXECUTION, ACKNOWLEDGMENT AND DELIVERY OF THE SAME.

BE IT ENACTED AND ORDAINED, by the Council of the Borough of Milesburg and it is hereby enacted and ordained by authority of the same in conformity with Act on Cooperation in Governmental Functions, 53 P.S. 487:

**SECTION ONE.**

A certain Agreement in substantially the same form as that Agreement attached hereto and made a part hereof as Exhibit A between the Borough of Bellefonte and the Borough of Milesburg for the sale of water by the Borough of Bellefonte to the Borough of Milesburg is hereby adopted, ratified and approved.

**SECTION TWO.**

The duration of the term of the Agreement is fifty (50) years renewable automatically unless notice is given pursuant to the terms of the contract.

**SECTION THREE.**

The purpose and objectives of the Agreement are the provision of potable, disinfected water by the Borough of Bellefonte to the Borough of Milesburg as provided in the attached Agreement.

**SECTION FOUR.**

Those provisions of the attached Agreement requiring financial outlays by the Borough of Milesburg are to be financed through grants.

**SECTION FIVE.**

No organizational structures other than that represented by the participating municipalities is necessary to implement the agreement.

**SECTION SIX.**

Any property, real or personal which is subject to the Agreement shall be acquired and managed as provided for therein.

**SECTION SEVEN.**

No new entity is to be created under the attached.

**SECTION EIGHT.**

The proper officers of the Borough of Milesburg are hereby required, requested, directed and authorized to make, execute, acknowledge and deliver all papers, forms, contracts and obligations necessary and proper to consummate the Agreement between the Borough of Milesburg and the Borough of Bellefonte and to do all acts necessary to complete the Agreement to operate the facilities contemplated thereunder in accordance with the terms of the agreement and to have all other necessary and proper authority to comply with the intentions of this Ordinance.
