

ORDINANCE NO. 337

AN ORDINANCE OF MILESBERG BOROUGH REGULATING THE  
USE OF THE MILESBERG COMMUNITY PARK

**WHEREAS**, the Milesburg Community Park serves the public and provides recreation space in Milesburg Borough; and

**WHEREAS**, the Milesburg Borough Council desires to adopt an Ordinance so as to regulate the use of the Milesburg Community Park so as to preserve its benefits for the use of the public; and

**WHEREAS**, the Milesburg Borough Council deems such regulation to be in the best interests of the citizens of the Borough and the users of the park.

**WHEREAS**, Ordinance No. 332 of the Borough of Milesburg is hereby repealed as of the effective date of this Ordinance. No other Ordinance or Regulations of the Borough are repealed and any and all remedies in said Ordinance, Regulations, or as otherwise provided for in law or equity are deemed to be cumulative with the remedies set forth herein.

**NOW THEREFORE**, it is Enacted and Ordained by Milesburg Borough Council as follows:

1. No alcoholic beverages are permitted on park grounds.
2. No animals are permitted on park grounds, excepting only service animals such as certified seeing-eye dogs.

3. Vehicles may be parked only in designated areas.
4. No open burning is permitted. Gas grills are permissible. Any charcoal fires must be completely extinguished after cooking use.
5. No motorized vehicles may be ridden on park grounds with the exception of assistive devices for the disabled.
6. No bicycles may be ridden on park grounds.
7. The park will close during its open season at dusk or 9:00 p.m.
8. Pavilion and other rental fees shall be as established from time to time by Resolution of Borough Council. All persons or organizations desiring to rent a pavilion or the concession stand shall provide the Borough with an executed Acknowledgement And Release as prepared by the Borough Solicitor or otherwise adopted by Council.
9. Any individual, group or organization that desires to lease the park, or portions thereof, for special events, or for recurring use on a scheduled basis, shall comply with the following conditions before such use can be scheduled:
  - a.) Provide the Borough with an executed Acknowledgement And Release as prepared by the Borough Solicitor or otherwise adopted by Council; and
  - b.) Provide the Borough with a certificate of insurance


evidencing liability coverage in favor of the individual, group or organization for the event(s) for which the park will be used, with such coverage limits as shall be established by Council, and naming the Milesburg Borough as an additional insured with respect to any events, use or activities conducted in the park.

10. Any violation of this Ordinance shall be, upon conviction, before the District Judge, shall be punishable by a fine of not less than \$100.00 or more than \$250.00.
