ATVs, dirt bikes, and side-by-sides are not permitted on Borough roads. Pennsylvania law (Title 75 §7721) prohibits operating these vehicles on public streets except for limited crossings. Violations are enforceable by the Ordinance Enforcement Officer.

No. 263 Control and Disposal of Dog Feces

Dog owners must clean up after their pets within the Borough limits. Failure to do so will lead to a citation without exception.

No. 360 Nuisances

Prohibited Nuisances: refuse and debris; garbage; abandoned vehicles; scrap metal storage; unmaintained vacant properties; overgrown vegetation; vermin or insect conditions; refrigerators or freezers kept outdoors; outdoor cats; barking dogs.

No. 302 Regulating Outside Burning within the Borough

Borough friendship fires using plain, unpainted firewood, along with BBQ pits and grills, are permitted. All other outdoor burning within Borough limits is prohibited and will result in a fine.
